

Fidelity Funds - Asia Pacific Dividend Fund

- This fund invests primarily in income producing equity securities in the Asia Pacific region.
- The fund is subject to investment, equities, emerging markets and foreign currency risk. Although the fund will generally invest in income-producing equities, it is not guaranteed that all underlying investments will generate dividends and higher dividend yields generally mean that there will be reduced capital appreciation.
- This fund can invest in derivative instruments which may involve additional risks. (For example, leverage may cause greater volatility.)
- Dividend of certain share classes, at the Board's discretion, may be 1) paid out of gross income while fees/charges may be charged to capital of the fund which will result in an increase in distributable income for the payment of dividends and the fund may pay dividend effectively out of capital; or 2) paid directly out of capital where the net income generated by the fund is insufficient to pay a distribution as declared. This will represent a return or withdrawal of part of the amount they originally invested or from any capital gains attributable to the original investment. Such distributions may result in an immediate decrease in the fund's net asset value per share.

Investment Objective 投資目標

The fund aims to achieve income and long-term capital growth principally through investments in income producing equity securities of companies that have their head office or exercise a predominant part of their activity in the Asia Pacific region. The Investment Manager will select investments which it believes offer attractive dividend yields in addition to price appreciation.

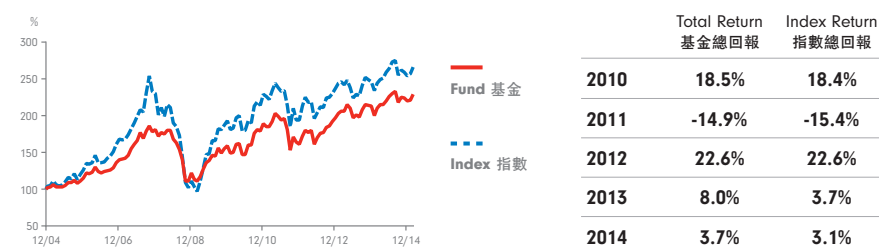
